

Pawnee Hills Golf Club Rules and Regulations 2019

The following rules and regulations, as amended, are adopted by the Board of Directors to facilitate and ensure the proper operation of the club. These rules and regulations are promulgated by the Board of Directors under their authority of the by-laws as passed by the Board of Directors.

1. Qualification for membership: Anyone 19 years of age or older desiring to become a member of the Club shall be required to purchase a membership certificate. Membership will not be limited because of any member's race, creed, ethnic background, or residence.
2. The dues and membership structure were adopted as follows:
 - A. **\$575.00** for a family membership per year. Everyone in the immediate family ([See Rule # 7](#)) can golf on this membership if paid for the current year.
 - B. **\$495.00** for an individual membership per year. Only one person can golf on this membership for the current year.
 - C. There will be a \$50.00 refund on both the family membership and the single membership, if the membership is paid by **March 31st** of the current year.
 - D. \$75.00 for a junior membership for singles age 18 and under. \$100 College Student Membership. \$330 50 Mile Radius Membership. If parents have a family membership, it is not necessary to get a Junior or College membership. [May play at all times including weekends.](#)
 - E. \$45.00 for a social membership if the member owns a certificate.
 - F. **All Members must pay their annual membership dues before playing.**

3. Payment of Dues: Dues are annual and shall become due on the 31st day of March and shall become delinquent on the first day of April. This due and delinquency date applies to all types of memberships, including social memberships. The member shall not be allowed to play the course until the dues are paid in full or allowed to use the Club House facilities if a social member.
4. Rate of Dues: The rate of dues shall be as set out in a separate schedule, which will be mailed to each member during the month of January each year. The rate of dues shall be set annually by the Board of Directors.
5. All certificate holders shall be voting members – one vote per certificate.
6. Membership Cancellation: Upon repeated violation of the Club rules, the Board of Directors may cancel the membership of the offending member.
7. Family membership includes husband and wife and children of the family under age 19. However, unmarried children 19 and older who are college students are included in the family membership until they reach the age of 23. All unmarried members shall have the right to extend the privileges of the Club to a [companion](#) with the purchase of a family membership.
8. Golf membership includes all golf privileges, clubhouse, and social activities.
9. Guests: No person not a member of the club shall be permitted to use the club facilities except as a guest of a member and except as herein provided and except as provided for green fees players.
10. No person shall be permitted to be guest of members more than a reasonable amount of times to be determined by the Board. The limitation shall not apply to private parties, fund raising activities, and other activities at the discretion of the Board of Directors.
11. Green Fees: **\$12.00** for 9 holes on weekdays and non-holidays. **\$17.00** for 18 holes on weekdays and non-holidays. **\$17.00** for 9 holes on weekends and holidays. **\$21.00** for 18 holes on weekends and holidays. **\$27.00** for all day except on weekends and holidays. (Holidays may be determined by the Board).
12. Cart Fees: The rental cart fees are set by the Board of Directors at **\$16.00** for 9 holes and **\$24.00** for 18 holes and **\$30.00** for all day. For those who bring a cart onto the premises without having a cart shed lease, a \$7.00 trail fee will be charged each time the cart is brought onto the premises for any play for the day.

13. Cart shed rent will be **\$155.00** for gas carts and **\$185.00** for electric cart due April 1st^l. Pay your cart shed rental by **March 31st to receive a \$25.00 early bird discount**
14. The holder of a cart shed lease will have the first option to renew their lease over any other applicant. If the number of applicants exceeds the number of cart stalls in the cart shed, those applicants submitting the applications earliest will have precedence. Certificate holders and members have first preference. **GOLF CART SHED LEASES MAY NOT BE SOLD OR TRANSFERRED.**
15. Driving Range Fees: the cost of a large bucket of balls is **\$4.00** and a small bucket of balls is **\$3.00**. Those wishing to purchase driving range privileges for the year can do so at the rate of \$75.00 for families. Single member driving range memberships are \$50.00.
16. The Club Manager shall have supervision of the Clubhouse and Course for the purpose of enforcing these rules.
17. The Clubhouse will be open on days of the week and times as set by the Board of Directors. Private parties are the exception. No service will be available after 12:00 a.m. or whatever the closing hours established by law for similar liquor licenses.
18. All guests of members shall have the privilege of playing golf upon payment of established green fees.
19. Pawnee Hills will not be responsible for any personal property left in the Clubhouse or on the Club grounds.
20. Alcoholic beverages may **not** be brought onto or taken off Club property. Alcohol must be purchased from the Clubhouse.
21. Green fee players have Clubhouse privileges for the day
22. **All golfers must register with the on-duty clubhouse manager before beginning play and check-in is required before starting your turnaround play.**
23. Each golfer must have his or her own set of golf clubs.
24. Only golf shoes with soft spikes may be used on the course. No baseball or football shoes are allowed or footwear that is obviously damaging to the greens.
25. Appropriate dress will be required for attendance at the course whether playing or in the Clubhouse. All members and guests shall wear shirts at all times.
26. Profanity or improper conduct will not be permitted. Any member or guest who shall exceed the bounds of propriety may be requested to leave the premises by the Club Manager, or any member of the Board, or any person in charge at the time.
27. Permission must be granted, by the Clubhouse manager or designee, to play five in a group and more than five players in a group is prohibited.
28. Starting play on any hole other than number one is not permitted without permission of the Clubhouse manager or designee.
29. Tee times may be taken 6 days in advance for members.
30. Non-member residents living in Nance County may pay green fees and play no more than five times during a calendar year.
31. Two golfers per cart maximum, whether the cart may be a rental cart or a privately owned cart.
32. Golfers under the age of 14 must be accompanied by an adult on weekends and holidays.
33. No one under the age of 14 is allowed to drive golf carts, whether rental or private, without adult supervision.
34. **Pawnee Hills has a no-smoking policy that will be enforced inside the Clubhouse.**
35. Additional rules for the use of the golf course and Clubhouse may be set by the Board of Directors, updated from time to time and posted.
36. These rules and regulations have been adopted by the Board of Directors at a regularly called meeting on October 13, 2013.
